If Kansas resident, please read and fill out section A, if non-Kansas resident, please read and fill out section B. Everyone must read and sign Section C.

A. Kansas military personnel: Pursuant to Kansas statute 79-5107(e), *not more than two (2) motor vehicles* may qualify for exemption from property taxation in Kansas if the resident individual is "*mobilized and deployed*" on the date of the application for registration of the vehicle(s). A separate exemption may be granted by the Kansas Board of Tax Appeals for RV-titled vehicles pursuant to K.S.A. 79-512 (e).

Kansas Resident (All must apply):

- ___ 1. The military person is shown on the title as the legal owner of the motor vehicle(s) for which the exemption is requested.
- ___ 2. The military person is on the full-time, regular military service of the United States. For purposes of this exemption, full-time regular military means a serviceperson, including a member of a reserve component who has been mobilized (ordered to active duty).
- ___ 3. The military person claims Kansas as his/her permanent state with the military.
- ___ 4. The military person is deployed on the date of application for motor vehicle registration. For purposes of this exemption, deployed means a serviceperson who is performing service pursuant to orders at a location, whether out of state or at a military base in Kansas, that prevents or makes it infeasible for him/her to return daily to the assigned housing usually occupied during off-duty time while on assignment at his/her permanent duty station
- ___ 5. The motor vehicle is not used in or arising from a trade or business.

Qualifying individuals may receive exemption for not more than 2 motor vehicles.

B. Non-Kansas Resident (All must apply):

- ___ 1. The military person is shown on the title as the legal owner of the motor vehicle(s) for which exemption is requested.
- ___ 2. The military person is in the full-time, regular military service of the United States. For purposes of this exemption, full-time regular military means a serviceperson, including a member of the reserve component who has been mobilized (ordered to active duty).
- ___ 3. The military person is absent from his/her permanent residence solely by reason of military orders.
- ___ 4. The military person resides in Leavenworth County.
- ___ 5. The motor vehicle is not used in or arising from a trade or business.
